As a precaution, we are posting the MTIP for public comment from August 18, 2023 - September 1, 2023. No changes have been made since it was presented to the Board in June.

RESOLUTION ADOPTING THE 2024-2033 METROPOLITAN TRANSPORTATION IMPROVEMENT PROGRAM

WHEREAS, the Transportation Advisory Committee (TAC) has found that the Metropolitan Planning Organization is conducting transportation planning in a continuous, cooperative, and comprehensive manner in accordance with 23 U.S.C. 134 and 49 U.S.C. 1607; and

WHEREAS, the TAC has found the Transportation Improvement Program (TIP) to be in full compliance with Title VI of the Civil Rights Act of 1964 and Title VI Assurance executed by each State under 23 U.S.C. 324 and 49 U.S.C. 794; and

WHEREAS, the TAC has considered how the TIP will affect the involvement of Disadvantaged Business Enterprises in the FHWA and the FTA funded project (Sec. 105(f), Pub. L. 97-424, 96 Stat. 2100, 49 CFR part 23); and

WHEREAS, the TAC has considered how the TIP will affect the elderly and disabled per the provisions of the Americans with Disabilities Act of 1990 (Pub. L. 101-336, 104 Stat. 327, as amended) and U.S. DOT implementing regulations; and

WHEREAS, the Metropolitan Transportation Plan (MTP) adopted on March 25, 2021 has a horizon year of 2045, and will met all requirements for an adequate Transportation Plan; and

WHEREAS, the programs and projects included in the NBAMPO TIP for FY 2024-2033 are financially constrained in accordance with State and Federal law; and

WHEREAS, the TAC has provided for a minimum 15-day public comment period and has held a Public Hearing for the proposed Transportation Improvement Program; and

WHEREAS, the TIP will serve as the project selection document for transportation projects within the New Bern Planning Area Boundary, and NCDOT may move projects and phases of projects without additional programming or project selection approval by the MPO within a three-year period, provided that financial constraint criteria are met;

NOW, THEREFORE, BE IT RESOLVED that the New Bern Area Metropolitan Planning Organization Transportation Advisory Committee adopts the FY 2024-2033 Metropolitan Transportation Improvement Program for the New Bern Metropolitan Area on this the 24th day of August 2023.







FHWA News USDOT Responds to Roadway Safety Crisis

In response to the unacceptable increases in roadway fatalities, USDOT has committed to the National Roadway Safety Strategy (NRSS), a comprehensive strategy of priority actions to significantly reduce serious injuries and deaths while working toward zero roadway fatalities. At its core, the NRSS adopts a Department-wide Safe System Approach focused on five key objectives: safer people, safer roads, safer vehicles, safer speeds, and post-crash care. One year after the launch of the strategy, recent efforts include: A 2023 report documenting progress on 29 actions and announcing 14 new ones for the next year. An online dashboard also offers current information.

Interactive maps that illustrate the significant impacts to communities of motor vehicle-involved deaths of drivers, passengers, and people outside of vehicles who were walking, biking, or rolling.

New Schedules for NC By Train

- Due to increased demand, NC By Train, North Carolina's passenger rail service, will offer additional trains and new schedules between Raleigh and Charlotte starting July 10.
