The Metropolitian Transportation Improvement Program (MTIP) is a subset of the adopted NC State Transportation Improvement Program (STIP) which identifies state and federall-funded transportation investments within the New Bern Area MPO. When NCDOT modifes the STIP, the New Bern Area MPO must also modify their MTIP to ensure that there is no delay in project funding or schedule.

Amendment 8 to the MTIP is being requested to allow NCDOT to obligate approximately \$7M in Vunerable Road User funding before the end of the federal fiscal year. This funding is used to strategically make travel safer for those people who are walking, biking or using mobility assistance devices. The following projects are being added to obligate funding: HS-2017DIV, HS-2017REG, HS-2017SW and HS-2015DIV, HS-2015REG, and HS-2015SW.

This Amendment also includes modifying two statewide projects by adding project breaks. A project break creates a new project and funding from the larger parent creating transparency. A project break can be easily identified by the letter at the end of the STIP number such as M-0563"D".

WHEREAS, any STIP amendment for new statewide projects or projects within the New Bern Area Metropolitan Planning Organization (NBAMPO) triggers the amendment of the MTIP; and

WHEREAS, Amendment 8 to the FY 2020-2029 MTIP is needed to add the following projects: HS-2017DIV, HS-2017REG, HS-2017SW and HS-2015DIV, HS-2015REG, and HS-2015SW and to add modify the following projects by adding project breaks: M-0563D and M-0563E; and

WHEREAS, the Transportation Advisory Committee (TAC) has reviewed the FY 2020-2029 Metropolitan Transportation Improvement Program and found the need to amend it; and

NOW, THEREFORE, BE IT RESOLVED that TAC of the New Bern Area Metropolitan Planning Organization adopts Amendment No. 8 to the FY 2020-2029 Metropolitan Transportation Improvement Program this the 16th day of August 2023.
