Ms. McRee advised any time modifications are made to the State Transportation Improvement Program (STIP) we have to modify the MTIP. There are 2 statewide additions, adding funds to the right-of-way acquisition account, and 7 statewide modifications, modifying funds at the request of IMD.

**9. US 70/I-42 Corridor Construction Update: *Wendi Johnson and Brad McMannen***

Ms. Johnson presented an update on the James City Improvements project, providing photos and videos that can be found on the project website. A few key changes to design are that the pedestrian bridge will be remaining in place, storm water retention basins have been added along the corridor, there will be an additional roundabout at the Grantham Road interchange, and there will be noise walls added on either side of US 70 at the beginning of the project entering James City.

Mr. Capehart presented an update on the Havelock Bypass and Section C projects, providing photos and videos that can be found on the project website. The bypass is currently 61% complete, with an anticipated completion date of Spring/Summer 2024. New drone footage is scheduled to be filmed next week.

The Section "C" project is the 6.6-mile corridor between the James City Improvements and the Havelock Bypass. Balfour Beatty was awarded the contract in January 2023. There are 3 intersections that will be upgraded to interchanges, Camp Kiro Rd, Fisher Ave, and Stately Pines Rd, similar design to the James City interchanges.

94 dropping below 50,000, CARTS has lost their urbanized designation. 5307 funds that

97 most impact on the new Omnibus fixed route system that runs solely within the  
98 urbanized area. It is currently paid by CARES Act funds which will run out June 30,  
99 2024.

**6. Adopt Amendment No. 8 to the Metropolitan Transportation Improvement Program (MTIP): *Deanna Trebil***

Amendment 8 to the MTIP is being requested to allow NCDOT to obligate approximately \$7M in Vulnerable Road User funding before the end of the federal fiscal year. This funding is used to strategically make travel safer for those people who are walking, biking, or using mobility assistance devices. ## **RESOLUTION ADOPTING THE 2024-2033 METROPOLITAN TRANSPORTATION IMPROVEMENT PROGRAM**

**WHEREAS**, the Transportation Advisory Committee (TAC) has found that the Metropolitan Planning Organization is conducting transportation planning in a continuous, cooperative, and comprehensive manner in accordance with 23 U.S.C. 134 and 49 U.S.C. 1607; and

**WHEREAS**, the TAC has found the Transportation Improvement Program (TIP) to be in full compliance with Title VI of the Civil Rights Act of 1964 and Title VI Assurance executed by each State under 23 U.S.C. 324 and 49 U.S.C. 794; and

**WHEREAS**, the TAC has considered how the TIP will affect the involvement of Disadvantaged Business Enterprises in the FHWA and the FTA funded project (Sec. 105(f), Pub. L. 97-424, 96 Stat. 2100, 49 CFR part 23); and

**WHEREAS**, the TAC has considered how the TIP will affect the elderly and disabled per the provisions of the Americans with Disabilities Act of 1990 (Pub. L. 101-336, 104 Stat. 327, as amended) and U.S. DOT implementing regulations; and

**WHEREAS**, the Metropolitan Transportation Plan (MTP) adopted on March 25, 2021 has a horizon year of 2045, and will meet all requirements for an adequate Transportation Plan; and

**WHEREAS**, the programs and projects included in the NBAMPO TIP for FY 2024-2033 are financially constrained in accordance with State and Federal law; and

**WHEREAS**, the TAC has provided for a minimum 15-day public comment period and has held a Public Hearing for the proposed Transportation Improvement Program; and

**WHEREAS**, the TIP will serve as the project selection document for transportation projects Statewide and within the New Bern Planning Area Boundary, and NCDOT may move projects and phases of projects without additional programming or project selection approval by the MPO within a three-year period, provided that financial constraint criteria are met;

**NOW, THEREFORE, BE IT RESOLVED** that the New Bern Area Metropolitan Planning Organization Transportation Advisory Committee adopts the FY 2024-2033 Metropolitan Transportation Improvement Program for the New Bern Metropolitan Area and Statewide on this the 15<sup>th</sup> day of September 2023.

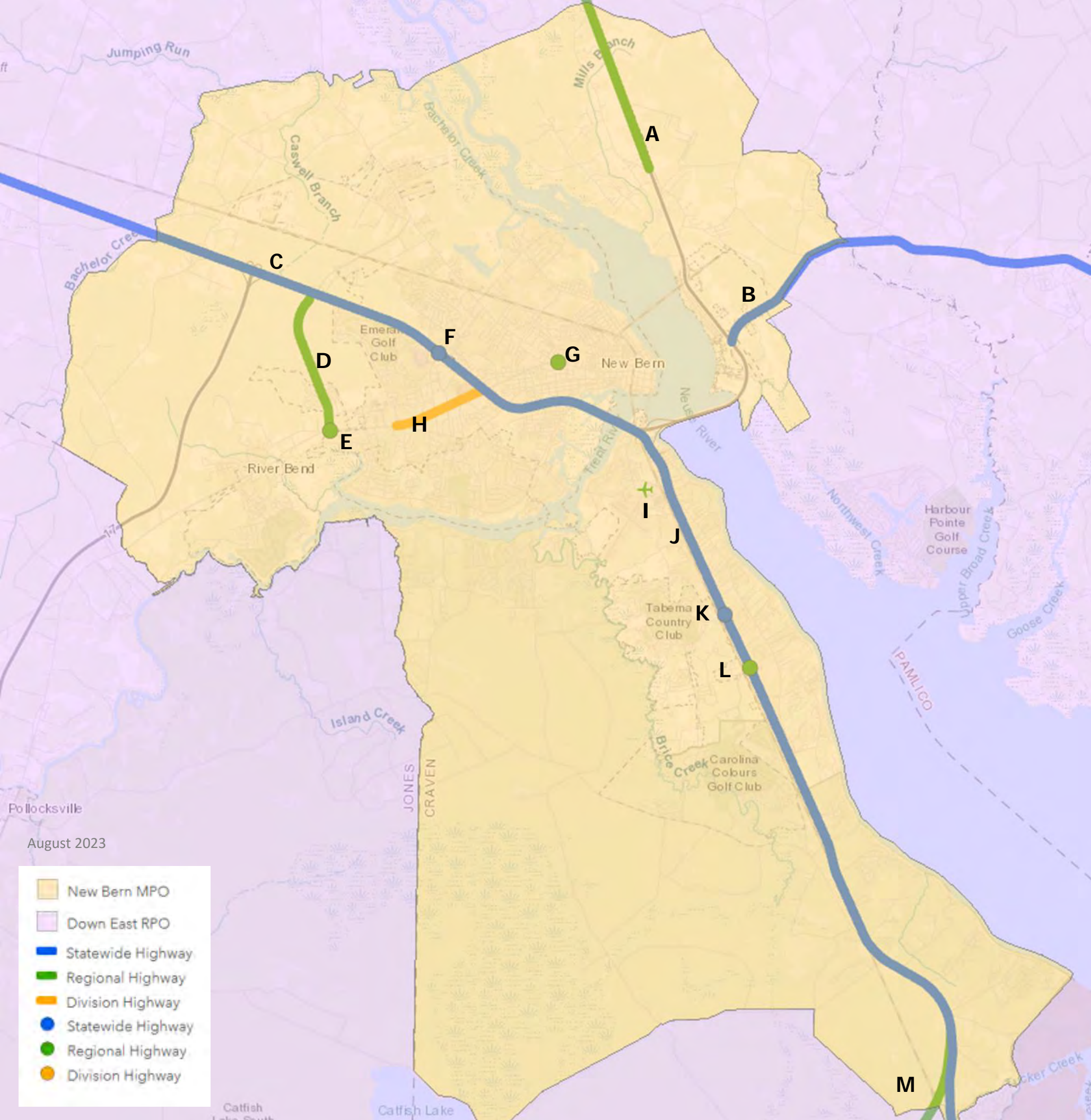

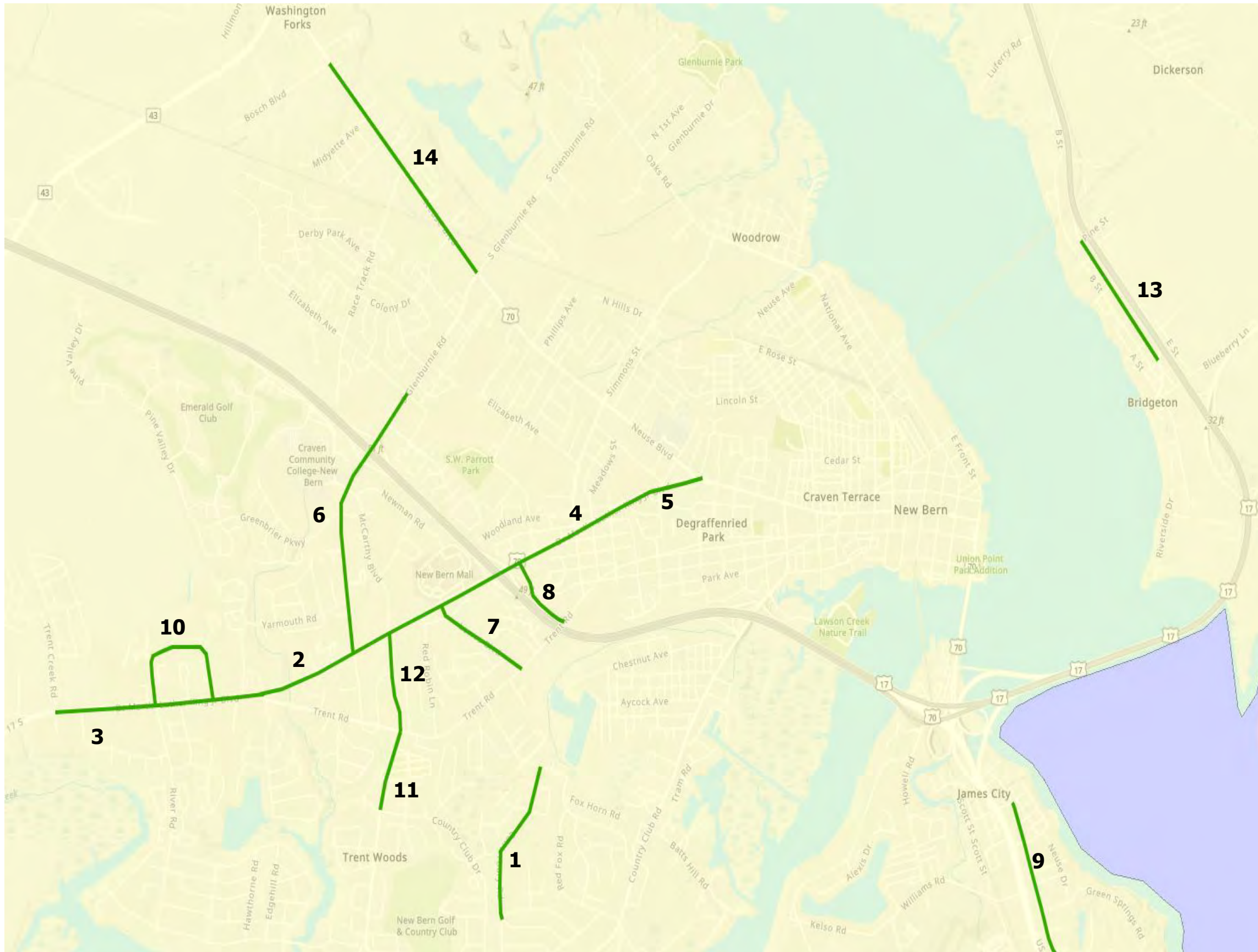
# P7 Bike/Ped Potential Projects

### USDOT Responds to Roadway Safety Crisis

In response to the unacceptable increases in roadway fatalities, USDOT has committed to the **National Roadway Safety Strategy** (NRSS), a comprehensive strategy of priority actions to significantly reduce serious injuries and deaths while working toward zero roadway fatalities. At its core, the NRSS adopts a Department-wide **Safe System Approach** focused on five key objectives: safer people, safer roads, safer vehicles, safer speeds, and post-crash care. One year after the launch of the strategy, recent efforts include: A **2023 report** documenting progress on 29 actions and announcing 14 new ones for the next year. An **online dashboard** also offers current information.

**Interactive maps** that illustrate the significant impacts to communities of motor vehicle-involved deaths of drivers, passengers, and people outside of vehicles who were walking, biking, or rolling.
