#### 7. FY 2024 Final Unified Planning Work Program (UPWP): Kim Maxey

The UPWP is a document updated annually, providing proposed budget allocations for the upcoming fiscal year, outlining accomplishments from the previous year, and establishing goals for the upcoming year. There were no changes to allocation amounts since the draft was approved in January.

Motion: Ms. Mitchell made a motion to approve the Final UPWP. The motion was seconded by Mr. Brinson and passed unanimously.

### 8. Adopt Resolution No. 6 to the Metropolitan Transportation Improvement Program (MTIP): Kim Maxey

Ms. Maxey advised any time modifications are made to the State Transportation Improvement Program (STIP) we are required to modify the MTIP. These modifications are to add construction and funding in FY23 that was not previously programmed.

Motion: Ms. Mitchell made a motion to approve Resolution No. 6 to the MTIP. The motion was seconded by Mr. Brinson and passed unanimously.

#### 9. Endorse NCDOT Established Performance Measure Targets: Kim Maxey

The resolution for the Targets for Performance Measures states that the MPO agrees to plan and program projects that contribute toward the accomplishment of the State's targets.

Motion: Ms. Alcoke made a motion to approve the NCDOT Established Performance Measure Targets. The motion was seconded by Mr. Brinson and passed unanimously.

#### **10. P 7.0 Discussion:** *Kim Maxey*

Ms. Maxey presented the updated P7.0 timeline. We are currently in the P7.0 Workgroup period where they meet monthly to finalize their processes. NCDOT SPOT office advised that two projects from P6.0 may be designated as carryovers in P7.0.
