31       **2.1.Call to Order:** Vice-chair Kirkland called the meeting to order.  
32

33       **3.2.Roll Call:** Roll Call was taken and a quorum was declared.

35       **4.3.Approval of today’s agenda:**  
36

37               **There was no official agenda for this meeting. The items to be discussed were**  
38               **specifically P5.0 project prioritization scores.**

39       **5.4.P. 5.0 Draft Division Projects Prioritization ranking and scoring: *Kim Maxey***

41               Ms. Maxey provided a spreadsheet to board members outlining the proposed scoring of  
42               Division projects. Ms. Maxey advised in this round, the MPO has more projects to score  
43               than points to allocate, therefore decisions will need to be made following the approved  
44               methodology.

46               Ms. Maxey relayed that she met with members of the NCDOT Division 2 office, as well  
47               as Division 2 MPO and RPO representatives. During the course of this meeting, it

48 became clear that the New Bern Area MPO project scores were too low to ensure funding  
 49 from the Division level. Therefore the chances of getting any projects funded at this level,  
 50 were very low.

51  
 52 Mr. Shorter advised that project ID A130385, TIP ID AV-5808, can be removed from  
 53 scoring, as his facility has already received funding for this project.

54  
 55 The NBAMPO has 1,100 points to score projects. This allows allocation of points to 11  
 56 projects. These points include one shared projects with the Down East RPO. The New  
 57 Bern Area MPO will donate 49 points to the Down East RPO to utilize on project  
 58 H090081-BA, which is a shared US 17 project.

59  
 60 Board members made it clear that they felt it was important to score projects in support of  
 61 as many modes as possible.
